Subsequently, she worked in a secure hospital, supporting vulnerable adults with violent and challenging behaviour, learning disabilities, and psychiatric issues.

Before commencing pupillage, Rebecca worked as a solicitor's agent in county courts across England. She represented both claimants and defendants in a variety of hearings, including small claims (road traffic accidents and credit hire), application hearings, and infant settlement approval hearings.
