## NOTABLE CASES

### Morris v MCE Insurance (2018 Leeds County Court – HHJ Gosnell)

Acting for the Appellant – Held on appeal that, a) a Claimant is bound by their signature to a credit hire agreement, b) *Irving v Morgan Sindall* (contingent liabilities) applies and c) that even if a credit hire agreement was somehow unenforceable, *Bee v Jenson* (the recovery of credit hire charges as a measure of general damages) would apply.
