NOTABLE CASES

Re H (2018)

Middlesbrough Family Court: Victoria was led by a Senior Junior on behalf of the Local Authority in a case concerning the death of a 1 year old child. The case involved complex medical evidence, exploring the interplay between the ingestion of methadone by the child and natural community acquired bronchopneumonia. The parents were represented by Queen's Counsel.

Re E-D (2018)

York Family Court: Victoria was led by a Senior Junior on behalf of the children in a case concerning a catastrophic brain injury to a baby. As well as involving complex and conflicting medical evidence, the case involved sensitive disclosure issues regarding a non-party child witness. The Local Authority and mother were represented by Queen's Counsel.

Re T (2018)

Middlesbrough Family Court: Victoria represented the father in contested care proceedings in respect of a child suffering from Type 1 diabetes. The case was unique on the facts and involved the capability of parents with learning difficulties to care for a child with complex medical needs.

Re A (2019)

Hull Family Court: Victoria was led by Queen's Counsel in a contested adoption. The case involved a niche area of adoption law.

Re B (2020)

Middlesbrough High Court: Victoria represented the child in a case involving interesting jurisdictional issues.
