Re B (2023)

Representing a local authority in care proceedings concerned with alleged intra-sibling sexual abuse (each of the other parties were represented by leading counsel)

Re R (2023)

Representing the surviving sibling in care proceedings focused upon the cause of death of a child who had suffered more than 60 injuries (led by Timothy Donnelly).

Re P (2023)

Representing a local authority in care proceedings concerning life-threatening injuries suffered by a two year old child.
